Coastal hazards and adaptation

The Resilient Coast project team is nearing completion of Phase 6 of the development of a Coastal Hazard Adaptation Strategy. This has included a review of risk (likelihood and consequence) of coastal hazard impacts for a diversity of built and natural assets across Douglas Shire, development of an approach to adaptation (adaptation response, adaptation options), and preparations for economic analysis in Phase 7.

In September, the project team presented the work to date to:

- The Resilient Coast Stakeholder Advisory Group
- Douglas Shire Councillors and Executive Leadership.

Further workshops will be held over October and November with the Douglas Shire communities and special interest groups.
